

#### About the band

Guitarist: Cayle, the mastermind behind Energy Commission's offensive imagery and the conception of the band itself.

Lead Vocals: Hamish, whose distinctive vocals give Energy Commission a new edge on the usual garage punk band.

Bassist: Jake, who has also played for The Brow Horn Orchestra and James Teague.

Drummer: Reuben, Cayle's elder brother who ran off to Melbourne to find himself a job. Wanker.

Energy Commission are a Perth-based four piece punk band. They bill themselves as being "molestation punk blues". A notable feature of the band is their edgy, shock-rock lyrics and live shows, which often feature cross-dressing and simulated acts of homoeroticism. Musical and stylistic influences include, but are not limited to, The Kinks, Iggy Pop and the Stooges, and the Dead Kennedys.

Energy Commission's initial image was formed when they found some jumpsuits in an op-shop with an "Energy Commission" logo. The band then grew from there, evolving into the band that aims to make you laugh, cry, cringe, and possible feel slightly aroused.

#### **Target audience**

Energy Commission appeals to a broad range of ages, from younger people into shock rock and punk, to older punters who remember when punk was still young, and enjoy seeing a new generation of rock. However, we would rather appeal to people wanting to

see something fresh, rather than a re-hash of 70s style Buzz Cocks, Sex Pistols-esque style imagery. This is safety pin through the nipple, rather than the nose. An easier list would be who this does NOT appeal to: the squeamish, the conventional, the reverent, and the homophobic.

#### Imagery and specifications

First and foremost, the design should grab the viewers' attention for all the wrong reasons. It should be irreverent and cringe-worthy, but able to make you laugh in a guilty pleasure type of way. This can be achieved through foul language, sexuality, and/or religious imagery. This project allows for you, the graphic designer, to really push the boundaries of decency. Or Indecency, sait twere. The colours should be typically "punky" colours – a combination of blacks, whites, reds, oranges. We would like to avoid pastel or softer colours - the designs should really stand out and convey the energy that the Commission brings to the stage.

Clichéd punk ideas that we would like to steer away from: safety pins, Mohawks, Union Jack flags, etc. We really want to forge our own image, focussing on the "sensuality" of the band, Further enclosed is a review from an Energy Commission gig to clarify the image that they convey.

Being as half of the band is from Armadale, perhaps a regional stereotype of the suburb would be suitable to incorporate into their image – thinking Centrelink, beer, durries, etc.

#### **Technical Specifications**

Out of this project, we would like to receive:

- A series of rough draft poster designs, roughly 4-5. These can even be hand drawn, as we will then decide on a few of these posters for final drafts designs
- Of these posters, we would like 1x A2 design, and 1-2x A3 designs
- We would like for these colours to be in full colour, as per the imagery guidelines.
   If time permits, or you have a moderately spectacular idea, we are open to the notion of having a black and white/greyscale
- Furthermore, for my own use while managing the band, I would like a banner type signature attachment for letterheads and e-mail use. I'm numerically illiterate when it comes to spatial skills, so you'll probably have to guide me through the process for deciding on an appropriate size for this sort of thing. The letterhead should be in JPEG format.
- If you have a preferred printing company, we are willing to work with them.
  If the band so chooses, they may want a digital copy of the posters. This should be in either JPEG or PSD format.
